The SAFR was used for approximately 20 years and closed in 2005. The SAFR was used for law enforcement pistol and rifle qualifications. The soil consists of Aeolian sediment of Loess. It is anticipated the area of greatest concern is the SAFR's berm face. This area is suspected to be impacted with lead bullets and bullet fragments. The Government, U.S. Fish and Wildlife Service, requires an environmental consultant (EC) to perform an environmental site assessment to plan, design, and implement a work plan to characterize the site in accordance with the Missouri Department of Natural Resources Brownsfields Voluntary Cleanup Program. All work shall be in accordance with all federal, state, and local rules and regulations. All respondents are encouraged to visit the job site. Exact locations of all affected utilities will be the responsibility of the Contractor. The Chautauqua SAFR was constructed in the 1960s and used by the US FWS Law Enforcement for pistol and shotgun qualifications. It was abandoned in approximately 1998.
