The Department of Energy (DOE) at the Savannah River Site (SRS) is contracted with Savannah River Remediation LLC (SRR) to manage and operate the legacy nuclear liquid waste (LW) system. The LW system consists of several facilities to safely receive, store, treat, and permanently dispose of radioactive waste. The mission of SRR is to treat and stabilize LW and close the older style LW tanks. Acceleration of tank closures is desired to better assure continued progress in accordance with the Federal Facility Agreement commitments among DOE, the Environmental Protection Agency, and the state of South Carolina. Closure of older style tanks starts with the bulk waste removal efforts. A cesium removal process to support bulk waste removal efforts is needed to support and accelerate tank closure. A readily deployable, supplemental cesium removal capability (ion exchange) has been determined to be advantageous in supporting this goal. The scope as described in the statement of work is to provide an ion exchange process that will remove radioactive cesium-137 from aqueous high-level waste (i.e., dissolved salt solution). The scope includes the Supplier providing a method of preparing any spent ion exchange resin or eluted cesium for Interim Safe Storage (ISS). SRR will retain these materials in ISS until such time it is processed for final disposition. The Supplier shall provide 1000 hours of technical support to assist SRR in the nuclear safety analysis, hazards analysis, installation, start-up testing, system acceptance, training of SRR operations personnel, and operating procedures development. The Supplier shall provide enough materials and consumables (e.g., resin, vessels, containment systems, and equipment) to process 625,000 gallons of salt solution, which will consist of approximately 100,000 Curies of cesium-137. The Air Force Life Cycle Management Center (AFLCMC) Acquisition Environmental and Industrial Facilities Division (WNVK) intends to award a competitive Contract for Hazardous Waste Management Plan Development for Air Force Plant 42, Sites 5 and 6 (Palmdale, CA). The contractor shall be required to develop a Hazardous Waste Management Plan (HWMP) and ensure that it is fully compliant with all federal, state, and local regulations. The HWMP shall include a waste analysis plan, training plan, emergency response plan, pollution prevention plan, waste stream inventory, collection site inventory, and waste profiles. The HWMP shall include a contingency plan and emergency procedures with capability for amendments to current requirements and change in status since the developed and completed HWMP. The HWMP shall be developed by contractor with AFP 42 Common Area oversight, who will implement the HWMP once completed. HWMP shall identify regulatory compliant policies and procedures for managing hazardous

wastes. All personnel who handle, generate, package, label or move waste must refer to this document when making waste management decisions. Contractor shall ensure HWMP compliance with California hazardous waste regulations, and with federal regulations that have not yet been incorporated into California rules (i.e., generators of hazardous waste in CA). Knowledge and experience with California hazardous waste rules is essential. Hazardous Waste management unit inspections shall include waste accumulation, waste storage, proper shipping and disposal, and required permits, recordkeeping and reporting. HWMP shall ensure that waste streams are properly characterized to determine whether or not they are hazardous wastes and have proper documentation with determination of any occupational or environmental health risk. All waste streams including restoration must be inserted into the HWMP. Should there be a transition from small quantity generator (SQG) to large quantity generator (LQG) for a short period of time for any episodic increases to their waste stream over the threshold, the storage of waste, developing the training plan, contingency plan, conducting required inspections for the month, monthly/bi-annual reporting, any fees and permits, and for transportation and disposal of the waste shall be addressed in the HWMP. Reference the California CUPA Forum under Generator Requirements Summary Chart. HWMP shall include Management of PCB wastes if these should exist. Also included shall be a section for handling spent batteries and a section for dealing with universal waste. HWMP inspections shall include internal self-assessment procedures and Facility audits. Exterior organization Inspections shall be included in the HWMP, such as the Environmental, Safety and Occupational Health Compliance Assessment and Management Program (ESOH CAMP); Certified Unified Program Agency (CUPA) inspection; and Department of Toxic Substance Control inspection. California CUPA has a Generator Requirements Summary Chart used for inspections of Large Quantity Generators (LQGs), Small Quantity Generators (SQGs), and Conditionally Exempt Small Quantity Generators (CESQGs). The revised final HWMP shall be reviewed and approved by a certified professional engineer prior to final submittal to the government. The contractor shall review signs and labels at waste points. If necessary, contractor shall install proper signs and labels. The contractor shall provide training to the members of the 412 Test Wing/OL upon government approval of the finalized HWMP.
