**NAICS:** 562910. DOE's Office of Environmental Management (EM) is currently in the acquisition planning stage for the "SRS Operations Acquisition (Post FY 2018)" at the Savannah River Site (SRS). During the week of October 24, 2016, DOE will conduct an Industry Day, a Community Day, and one-on-one sessions in support of the upcoming procurement for Operations Acquisition (Post FY2018) Requirement at SRS. The current Maintenance & Operations contract at SRS expires July 31, 2018, and is a major component of the overall SRS work scope and contracting structure. The goal of the planned events is to inform interested parties of the process that will be followed to procure the Site Operations Requirement, and to provide an overview of the major Elements of Scope. The draft Elements of Scope can be found under "Industry Day" at <https://www.emcbc.doe.gov/SEB/SRSPostFY18Ops>. The Industry Day and Community Day presentations will provide a site overview and technical discussion of the major elements of scope for the anticipated procurement, and encourage industry and community feedback to aid DOE in the development of the acquisition strategy. The 30-minute one-on-one sessions are provided as an opportunity for interested parties to present their thoughts and suggestions on the procurement. DOE recognizes the importance of including the public and community stakeholders at an early stage of the process. These activities are for informational purposes only. Attendance at any or all these events is not mandatory. The government will not reimburse any contractor for expenses related to attendance at these activities. Presentation materials will be available on the procurement website at a later date. Prior to the Industry Day, DOE intends to publish a Request for Information (RFI) incorporating the elements of scope, seeking interested parties with specialized capabilities who meet all or part of the requirements, and soliciting feedback from contractors and other interested parties regarding options for innovative approaches for the division of scope elements as well as insight into contracting options to achieve the EM goals. The INDUSTRY DAY WILL BE HELD ON OCTOBER 24, 2016, at the Doubletree Augusta Hilton Hotel located at 2651 Perimeter Pkwy, Augusta, GA 30909. Check-in will begin at 8:00 am ET and the meeting will begin at 9:00 am. The event is anticipated to conclude at approximately 12:00 noon. DOE will hold one-on-one sessions to obtain constructive input from interested firms regarding the procurement. The one-on-one sessions are provided as an opportunity for interested parties to present their thoughts and suggestions on the procurement, including but not limited to the questions included in the RFI. DOE will consider all input but will not accept any company marketing material. Any presentation materials shall be in hard copy, as computer equipment will not be provided nor allowed. Furthermore, no recording, copying, or transcription devices will be allowed during the one-on-one sessions by attendees. The one-on-one sessions will be held October 24 (from 1:00 PM - 5:00 PM) and October 25-26, 2016, at the Doubletree Augusta Hilton Hotel. The one-on-one sessions will be scheduled in 30-minute increments on a first-come, first-served basis. Registration for one-on-ones is limited to 5 representatives from each company. DOE will hold a Community Day on October 27 at the Doubletree Augusta Hilton Hotel. During the Community Day, DOE will provide briefings on the scope of the work and the acquisition process. Members of the community will also have the opportunity to ask questions and meet with DOE one-on-one. Check-in will begin at 8:00 am ET; the meeting will begin at 9:00 am and end at about 12:00 noon (local time); and one-on-one sessions will be scheduled in the afternoon on a first-come, first-served basis. The Northwestern Division (NWD) of the U.S. Army Corps of Engineers has a requirement to acquire Architect-Engineer Hazardous, Toxic, and Radioactive Waste (HTRW)/Environmental Indefinite Delivery Contracts (IDC) for execution of its environmental mission. The work will be located within EPA Region 2 and the NWD boundaries (the Kansas City, Omaha, and Seattle Districts), with the majority of the work in EPA Region 2. In support of this effort, the Government intends to award contracts to five unrestricted firms sharing \$120M in total contract capacity (the Contracting Officer has the discretion to adjust that number). THIS ANNOUNCEMENT IS UNRESTRICTED AND OPEN TO ALL BUSINESSES, regardless of size. The NAICS code for this procurement is 541330, Engineering Services. The period of performance for each contract will include a base period of five years. It is anticipated that the contracts will be awarded by August 2017 or earlier. Task orders will be issued as the need arises during the contract period. Task orders may be awarded as either fixed-price or cost-reimbursement type orders. Due to the nature of the requirements, projects are typically completed in phases, such as preliminary assessment, remedial investigation, feasibility study, design, engineering during construction, post-construction long-term operations or monitoring, and post-construction optimization or modifications to existing systems and remedies. The project scope will be reviewed to determine whether the requirement can be accomplished using a firm-fixed-price task order or whether uncertainties will require the use of a cost-reimbursable task order. Selected firms will work on a variety of projects, including, but not limited to investigation and design of remedies for contaminated soil, groundwater, soil gas and indoor air, contaminated sediments, radioactive and mixed wastes, landfills, underground storage tanks, and fueling systems. Interested firms having the capabilities to perform this work must submit one original plus five copies and one CD or DVD with searchable Adobe PDF files of one SF330 (03/2013 edition) for the Prime/JV firm that includes all team consultants. The instructions for SF330 require certain project specific details for each of the 10 projects presented in Section F of the SF330. Under specific task orders, the contractor will be required to support the activities and mission of EPA to 1) monitor water quality and manage and display water quality information; 2) assess water quality conditions and report on those conditions to the public and Congress; and 3) advance the protection and restoration of the nation's watersheds and water bodies. Protection and restoration of watersheds and water bodies can be accomplished through a) the development and implementation of Total Maximum Daily Loads (TMDLs); b) ensuring the use of point and nonpoint source pollution controls; c) the development of tools for ecosystem restoration; d) the identification and protection of healthy watersheds; and ultimately e) the improvement of water quality. The Government anticipates multiple-award IDIQ contracts each with a 5-year ordering period, allowing for both firm-fixed-price and cost-plus-fixed-fee task orders with a total level of effort of 783,840 hours (if all option quantities are exercised). THE SOLICITATION WILL BE ISSUED ON A FULL AND OPEN COMPETITION BASIS, NAICS code 541611, with a size standard of \$15M.
