NAICS: 611430. THIS ACQUISITION IS SET ASIDE 100% FOR SMALL BUSINESS. EPA Region 5 is seeking contractor support for a two-day RCRA inspector training course. The training will be conducted under a fixed-price contract. The primary purpose of this request is to procure highly trained instructors who have worked with U.S. federal government agencies, preferably EPA, to enhance overall effectiveness of federal, state, and tribal compliance monitoring and enforcement staff. This advanced inspector training, including training in RCRA air toxics regulations, will help reinforce competencies, enhance performance, and help ensure that EPA, state, and tribal inspectors can contribute fully and effectively to the successful accomplishment of EPA's mission. RCRA air toxics have been identified as a National Enforcement Initiative (NEI) for FY17-FY19, and preliminary information indicates potential compliance problems with RCRA-C air emission requirements. The area of air toxics regulations has been identified as one where additional training is needed for RCRA inspectors along with other advanced RCRA topics. NAICS: 562910. This is a DRAFT RFP and Site Visit announcement ONLY; no final RFP exists at this time. A Site Visit is planned for November 1 and 2, 2016, for the Live Task Order at White Sands Missile Range (WSMR), New Mexico, from 8:30 AM - 4:00 PM (MT), both days. Two days are required to tour all locations. The Site Visit will be limited to two persons per Offeror. If interested in attending, YOU MUST REGISTER TO ATTEND BEFORE NOON CT ON OCTOBER 12, 2016. Requests delivered after the Noon CT deadline will not be accepted due to Government transportation coordination requirements on WSMR. A DRAFT RFP dated 4 October 2016 is one of several DRAFT attachments to the FedBizOpps notice. These materials are intended to provide background information on a future procurement sufficient to enable interested vendors to submit questions and comments prior to any formal release. It is anticipated that if a Final RFP results from this notice, it will be to award a multiple-award IDIQ contract for approximately \$200M. The Government contemplates award of a maximum of 8 IDIQ contracts as competitive small business set-asides, of which one may be reserved for a Woman-Owned Small Business. The anticipated NAICS code is 562910, with a size standard of 750 employees. Anticipated work would be conducted in the program areas that fall under the Army Environmental Cleanup Program, i.e., Installation Restoration, Military Munitions Response, Base Realignment and Closure, Compliance Cleanup, and/or Operational Range Assessment. The contract will support the Army's Environmental Cleanup Program, replacing the existing Environmental Remediation Multiple Award (ERMA) IDIQ contract, which is nearing expiration. The Contractor shall be required to provide a wide range of environmental investigations, remediation, and munitions response activities at various installations and locations throughout the United States, including the territories of Puerto Rico and the Virgin Islands. The Government anticipates awarding firm-fixed-price Task Orders against the Base Contracts.

Task orders issued under the Performance Work Statement (PWS) will support EPA's Office of Research and Development, National Center for Environmental Assessment (NCEA), in developing and updating Provisional Peer-Reviewed Toxicity Value (PPRTV) assessments, as well as research related to prioritizing chemicals for the PPRTV program, expert consultation, and research on cross-cutting issues related to new alternative toxicity data sources and technologies. In addition, the contract will entail work associated with cumulative risk assessment, including human and non-human biota, and chemical mixtures risk assessment, supporting the advancement of the science in community-based risk assessment. NCEA provides health assessments to the Superfund Program through the PPRTV Program. Through PPRTVs, NCEA provides EPA's Office of Land and Emergency Management (OLEM) with interim toxicity values on accelerated schedules and for chemicals with data that are sufficient to develop screening level values for priority setting but insufficient to support IRIS toxicity values. Chemicals are selected according to priorities set by NCEA and the Superfund Program. PPRTVs are OLEM's preferred source of peer-reviewed health

assessments when IRIS values are not available for determining cleanup levels at Superfund sites. Like IRIS assessments, PPRTVs are developed consistent with Agency risk assessment guidelines and methodologies. The U.S. Environmental Protection Agency, Office of Acquisition Management is conducting market research for informational purposes only to identify potential small business sources (including 8(a), veteran-owned, service-disabled veteran-owned, HUBZone, disadvantaged, and woman-owned small business concerns) with the capacity and technical capability necessary to successfully perform the requirement described in the draft statement of work attached to the FedBizOpps notice. This requirement will provide enforcement support to EPA's Mobile Source Enforcement Branch within the Air Enforcement Division, in the Office of Civil Enforcement, for Clean Air Act mobile source regulatory and enforcement activities. The majority of the work will involve field inspections, investigations, and audits. These services are currently provided under contract EP-W-12-007 with Eastern Research Group (ERG). Notwithstanding the government's option to exercise term extensions, the current contract is scheduled to expire on March 5, 2017. The proposed acquisition is estimated at 117,500 hours, including all options and optional quantities. The Government anticipates awarding a 5-year, cost-reimbursement type contract under FAR Part 15, Contracting by Negotiation Procedures. The NAICS code for this procurement is 541620, with a small business size standard of \$15M in annual receipts. This is a sources sought notice for written information only and is not a request for technical or cost proposals. These contracts may support all ORD laboratories, centers, and offices, as well as other EPA organizations, such as Regional and Program Offices that conduct research projects that could be supported under the scope of the Peer Review Performance Work Statement (PWS). EPA is seeking a contractor to perform the following tasks: (1) provide peer review support services, including scientific and technical peer reviews, as well as editorial peer reviews of scientific and technical articles; (2) provide workshop and meeting support in association with the peer review process, including scientific workshops and meetings specific to peer review activities; (3) develop documents and complete papers pursuant to Agency-related issues; (4) prepare instructional materials to communicate the purpose and scope of the Agency's guidelines; and (5) provide literature searches in support of the Agency's mission. The Government anticipates award of IDIQ multiple-award firm-fixed-price and time-and-materials task-order contracts, with a single ordering period of 5 years. EPA intends to award up to two contracts, totaling ~\$4.2M. THE ANTICIPATED SOLICITATION RELEASE DATE IS IN THE EARLY DECEMBER TIME FRAME, and the close date shall be ~40 days thereafter. THE SOLICITATION WILL BE ISSUED ON A FULL AND OPEN COMPETITIVE BASIS, with no small business set-aside(s). All responsible sources may submit a proposal for EPA consideration. The NAICS code is 541990, with a size standard of \$15M. Award(s) will be made using the Lowest Price Technically Acceptable source selection process.
