NAICS: 541380. This is a Sources Sought Notice and is only for collecting information. This Market Survey is being conducted to determine if there are adequate Small Businesses, HUBZone, 8(a), Woman-Owned, or Service-Disabled Veteran-Owned Business contractors for the following proposed contract: a single-award Task Order Contract (SATOC) for laboratory analytical services and related efforts in support of the U.S. Army Corps of Engineers (USACE), Philadelphia District. The contract is for the chemical analysis of soils, sediments, sludges, groundwater, surface water, oils, waste, air, and other environmental samples. Analytical services will be performed by the Contractor to support Military, Superfund, Civil Works, and "Support for Others" activities of the USACE Philadelphia District. The Philadelphia District performs various field investigations for hazardous, toxic, and radioactive waste (HTRW) projects that involve collection of primary samples, split samples, and/or quality assurance samples from various hazardous and toxic waste sites located within District Boundaries. Work involving sites outside the District may also be required. Award of an indefinite-delivery type contract is anticipated in January/February 2017. The laboratory shall maintain active and current National Environmental Laboratory Accreditation Program (NELAP) certifications for the New Jersey Department of Environmental Protection (NJDEP), including air certification, throughout the term of this contract in order to be awarded task orders. The laboratory shall also be certified as a DoD Environmental Laboratory Accreditation Program (ELAP) laboratory that is compliant with the current version of the DoD Quality Systems Manual (QSM) and the specified SW-846 methods in the scope. Any laboratory currently possessing these certifications may submit a proposal. Copies of the certifications must be provided as part of the submittal. The laboratory must be also able to produce Automated Data Review (ADR) and Stage Electronic Data Deliverables (SEDD) in compliance with electronic Quality Assurance Project Plans (QAPPs) as well as EDDs in the format required for the USEPA Region 2 EQUIS database system. The laboratory is required to be able to provide PDF fully searchable structured complete data packages (including QC and raw data), invoice information, EDD exports and the ability to auto email data once the data is complete. The laboratory must indicate whether it is capable of providing data results in electronic format directly from a Laboratory Information Management System (LIMS) as opposed to manual manipulation. The period of performance shall be for a base year of 12 months plus 4 option years. The total for the base and all option periods shall not exceed \$2.5M. NAICS: 562910. The purpose of this notice is to obtain information regarding the availability and capability of all qualified sources to perform potential multiple awards for Environmental Remediation Services. The Eastern Region of the U.S. Forest Service is conducting market research to understand the numbers and types of contractors who have

the capability and are interested in performing 3 types of professional environmental services: (1) Emergency Hazardous Materials Release Response, (2) Non-CERCLA Site Investigation that may include Site Cleanup and Remediation, and (3) Cleanup and/or Characterization of Illegal Marijuana Grow Sites. The contractor shall provide all necessary labor, materials, and transportation to meet the requirements of these projects. The Forest Service also seeks potentially qualified sources, with indication of business size classification, including SBA-certified 8(a) Small Business, SBA-certified HUBZone Small Business, Small Disadvantaged Business, Veteran-Owned Small Business, Service-Disabled Veteran-Owned Small Business, and Small Business. This requirement supports the Forest Service, Eastern Region 9, which includes 15 National Forests located throughout the northeast United States. The states are Missouri, Minnesota, Michigan, Wisconsin, Illinois, Indiana, Ohio, West Virginia, Pennsylvania, New York, Vermont and New Hampshire. Some of the work may encompass private land adjacent to these National Forest lands. Services include but are not limited to the following: (1) Collect water, soil, sediment, wipe and air samples, (2) Obtain technical data, (3) Waste classification and profiling, (4) Waste transportation and off-site disposal, (5) Provide technical data reports, (6) Identify recommendations for remediation, (7) Perform site remediation and restoration, (8) Participate in meetings with the Government and other regulatory agencies to provide technical response, (9) Provide investigation and clean-up of hazardous materials and hazardous solid wastes and Associated contamination on National Forest System lands, (10) Provide emergency response services to a hazardous materials release or spill on National Forest System lands, and (11) Contact and coordinate with appropriate regulatory agencies to determine if the Task Order (or work conducted within performance of the Task Order) is subject to the review and approval of the regulatory agency, for example USEPA and/or a state regulatory agency. The mission of the Superfund Research Program (SRP) is to support research and training that advances society's scientific and engineering knowledge that is needed to protect human health and the environment from hazardous substances. The knowledge acquired in this program integrates environmental health science and the related environmental sciences and engineering disciplines with the goal of improving the nation's public health. The SRP is a university-based research program composed of three independent grant programs: (1) the multiproject/core research centers (Centers), (2) the individual investigator research grants, (3) the Small Business Innovative Research/Small Business Technology Transfer Research (SBIR/STTR) grants and (4) the Occupational and Safety Education Programs on Emerging Technologies. The purpose of this contract is to communicate and multi-laterally disseminate the science and technology that is developed by the SRP by establishing mechanisms that ensure research outcomes of the three different SRP grant programs are readily available to the program's stakeholders. As part of achieving this goal, the contractor will be responsible for SRP information management and organization as well as support of communication and information technologies.
