## REVEGETATION SERVICES ON A CLOSED LOW LEVEL AND MIXED WASTE RADIOACTIVE LANDFILL AT THE NEVADA NATIONAL SECURITY SITE (SRCSGT)

**NAICS:** 562910. Perform complete revegetation services on a closed low-level and mixed-waste radioactive landfill at the Nevada National Security Site. The landfill was closed with a soil cover in 2011 with the initial vegetation effort completed in December of that year. Vegetation monitoring in May 2013 revealed that seed germination and plant establishment were below expectations. Since that time two additional test plots using seed were attempted without success. The landfill cover is required to be vegetated by the closure agreement with the state of Nevada. All information gathered during the previous efforts will be provided to the successful bidder, including soil analysis data from 2014. The site is divided into 4 distinct but adjacent soil covers, totaling approximately 50 acres. \*\* The contract will consist of three task orders: (1) Completion of a revegetation plan to outline the most effective method to perform the revegetation. This study may include soil sampling and analysis, geotechnical analysis, or any other testing deemed necessary. (2) After the plan is complete and approved, revegetation of approximately 10 acres will be performed and evaluated. (3) Revegetation of the remaining portion of the site completed in the following season. \*\* Services are to include periodic monitoring to ensure that the vegetation is progressing as desired. Revegetation should be accomplished with either seedling or transplants or a combination of both. Species are to be native to the area and chosen based on the specific site conditions. Typical species for the area are *Achnatherum hymenoides* (Indian ricegrass), *Ambrosia dumosa* (white bursage), *Atriplex canescens* (fourwing saltbush), *Atriplex confertifolia* (shadscale), *Baileya multiradiata* (desert marigold), *Elymus elymoides* (squirreltail), *Encelia farionosa* (brittlebush), *Ephedra nevadensis* (Nevada ephedra), *Larrea tridentata* (creosote), and *Sphaeralcea ambigua* (desert globemallow). The objectives of this project are to address key research needs by establishing performance benchmarks for suspect screening analysis (SSA) and non-targeted analysis (NTA) methods in environmental and biological samples. To date, there are few, if any, analysis and reporting standards for studies utilizing SSA and NTA methods. As such, method performance characteristics (e.g., percentages of false negatives and positives) are difficult to discern, and the true potential of these methods remains unknown (and unrealized). EPA's main interests are therefore identifying and communicating the state-of-the-science for SSA and NTA methods via systematic execution of carefully designed and controlled experiments.

in coordinating WQS information management and analysis; providing program-related technical support, outreach, training, education to Regions, states, Indian tribes, and other stakeholders; providing technical support for implementation of WQS including use attainability analyses, environmental assessments, economic benefit analysis, and TMDL calculations, including use of geographic information systems, multi-media environmental fate and transport models, and water quality based permitting; providing technical support for developing and managing cross-media and multi-agency policies to ensure standards and exposure goals are attained; and assisting EPA in coordinating policies with our partners in other federal agencies (especially the U.S. Fish and Wildlife Service and the National Marine Fisheries Service) to insure all legal mandates are met.
