The U.S. Fish and Wildlife Service (USFWS) has a requirement for a Biologist to assist the Vieques National Wildlife Refuge (VNW, Puerto Rico) to liaison between the USFWS and other parties involved in the CERCLA remediation process on the Refuge. The person is required to have knowledge of the VNW / USFWS mission for the protection and conservation of flora and fauna species within the VNW in addition to safety, vehicle, PPE, and other regulations related to biology labor operations on the refuge. The person should also be knowledgeable of CERCLA as it pertains to human health, environmental health risk assessments, and the cleanup being conducted by the U.S. Navy in Vieques. In addition, the position will assist with other duties that might include restoring wildlife habitat by removing nonnative invasive plants, collecting native seeds, and supporting propagation of native plants in areas where the cleanup efforts have cleared vegetation in different areas throughout the Refuge. EPA intends to award a contract to provide economic/benefits analysis services, control strategy development, regulatory impact analyses, development of analysis methods and tools, sensitivity analysis and uncertainty/variability characterizations, database support, analytical computer models, graphical information systems, and review of data inputs for selection and evaluation of regulatory alternatives for the control of air pollutants. EPA anticipates the award of a cost-plus-fixed-fee, level-of-effort term (work assignment contract) with a 60-month performance period consisting of a 12-month base period and four 12-month option periods. The estimated level of effort is approximately 10,000 base hours plus approximately 20,000 optional hours for the base period and each of the four option periods. RELEASE OF THE RFP IS ANTICIPATED ON OR ABOUT JULY 28, 2016, and proposals will be due 45 days after the RFP issue date.
