The work covered under the Performance Work Statement involves the professional services necessary to complete the CERCLA Vapor Intrusion (VI) and SUMMA collection reports for AOU-1 field and laboratory sample activities by a third-party credentialed QA/QC expert. The Veteran's Healthcare Administration (VHA) -- designated the PRP for the 700 South-1600 East PCE Plume Superfund site in June 2013 -- signed a Federal Facilities Agreement (FFA) on February 25, 2016, between the Department of Veteran's Affairs, U.S. EPA Region 8, and Utah Department of Environmental Quality. The FFA lays out specific timeframes, milestones, and due dates for work performed by VHA to meet its CERCLA obligations. Performance of the tasks identified in this PWS requires a short turnaround time frame (~30 calendar days for the draft report and 60 calendar days for the final report) for VHA to complete a remedial investigation report for regulatory review and meet established timeframes within the FFA. The Contractor shall perform an independent evaluation to determine the adequacy and usability of the 2015 HAPSITE VI surveys and USEPA TO-15 SUMMA confirmation sampling and confirm the work was conducted in accordance with the AOU-1 "Protocol for Performing Indoor Air and Near-slab Soil Gas Assessment" and EPA's "Guidance on Environmental Data Verification and Data Validation" (EPA QA/G-8, November 2002). USCG Base Ketchikan intends to purchase the following: Contractor administrative and logistics services to support a U.S. Coast Guard-led effort to develop policy on use of chemical dispersants in the coastal zone of certain Alaska subareas covered by the new "Dispersant Use Plan for Alaska." The new dispersant use plan details separate dispersant use protocols for the Preauthorization Area and the Undesignated Area (i.e., the Case-by-Case protocol). One special requirement for establishment of the Preauthorization Areas is for the Coast Guard Federal On-Scene Coordinator (FOSC), working in conjunction with the EPA FOSC and State of Alaska On-Scene Coordinator (SOSC), to lead an effort to engage federal and state natural resource trustees, federally recognized tribes, and stakeholders in a process to identify locations where dispersant use should be avoided within the Preauthorization Area where the Preauthorization Area overlaps their respective Subarea Contingency Plan (SCP). Any so-identified locations shall be included in Section I (Dispersant Use Avoidance Areas) of each SCP and posted online. This process shall be completed within 24 months following ARRT approval of this plan. Any avoidance area identified in a SCP shall no longer be considered part of the Preauthorization Area for dispersant use; rather, the avoidance area shall be automatically reclassified as an Undesignated Area where requests for dispersant use shall follow the process for Case-by-Case Dispersant Use Authorization. The USCG is soliciting contractor administrative and logistics assistance in carrying out the necessary steps to advise stakeholders of this process and to seek, gather, and assess their inputs to inform dispersant use policy development in these five subareas.
