The EPA Office of Ground Water and Drinking Water Technical Support Center requires contractor support to provide technical, analytical, and administrative support services for the Unregulated Contaminant Monitoring Regulation (UCMR). Section 1445(a)(2) of the Safe Drinking Water Act (SDWA), "Monitoring Program for Unregulated Contaminants," requires that once every five years EPA issue a new list of no more than 30 unregulated contaminants to be monitored by public water systems (PWSs). This Unregulated Monitoring Rule requires PWSs to collect occurrence data for contaminants that may be present in drinking water but are not yet subject to EPA's drinking water standards set under SDWA. This rule benefits public health by providing EPA and other interested parties with scientifically valid data on the national occurrence of selected contaminants in drinking water. This dataset is one of the primary sources of information on occurrence, levels of exposure, and population exposure the Agency uses to develop regulatory decisions for contaminants in the public drinking water supply. SDWA requires that EPA (1) have direct implementation responsibilities (with state assistance through Partnership Agreements) (2) enter the monitoring data into the Agency's publically available National Contaminant Occurrence Database (3) ensure that systems serving a population larger than 10,000 people, as well as a nationally representative sample of PWSs serving 10,000 or fewer people, are required to monitor. EPA must also vary the frequency and schedule for monitoring based on the number of persons served, the source of supply and the contaminants likely to be found. The final UCMR 4 (<https://www.epa.gov/dwucmr/fourth-unregulated-contaminant-monitoring-rule>) identifies eleven analytical methods to support water system monitoring for a total of 30 chemical contaminants, consisting of nine cyanotoxins and one cyanotoxin group; two metals; eight pesticides plus one pesticide manufacturing byproduct (hereinafter collectively referred to as pesticides); three brominated haloacetic acid disinfection byproducts groups; three alcohols; and three semivolatile organic chemicals. The proposed contract will have a base period consisting of 12 months with five option periods of 12 months each, for a total potential period of performance of six years. Total maximum level of effort for this six-year period of performance is 104,400 direct labor hours. It is anticipated that a cost plus fixed-fee/level-of-effort contract will result from this solicitation. This is a follow-on-requirement, of the current EPA contract EP-C-12-057 with Great Lakes Environmental Consultants. THE ANTICIPATED SOLICITATION RELEASE DATE IS LATE APRIL 2017, and the close date shall be approximately 30 days thereafter. THE SOLICITATION WILL BE ISSUED AS A SMALL BUSINESS SET-ASIDE. NAICS: 562910. The Environmental Protection Agency (EPA) Region 3 is extending Superfund Contract Nos. EP-S3-07-04, EP-S3-07-05, EP-S3-07-06, and EP-S3-07-07 for a period of one year with one 1-year option and two 6-month options, which will be exercised only if necessary. The purpose of these extensions is to allow the Agency time to implement its new Remedial Acquisition Framework (RAF). Currently, Region 3 uses the above four single-award Remedial Action Contracts (RACs) to design, construct and oversee the execution of Superfund remediation. The RAF is the result of extensive acquisition planning over the past five years, which has taken time due to the magnitude of the new program and an in-depth and profound organizational culture change which has resulted in the reformation of the EPA's remediation business model. The new business model is based on extensive market research which encompasses multiple Sources Sought notices, Requests for Information, a draft request for SF 330s, and two public webinars with over 400 participants each. The RAF is an entirely new concept of operations for future Superfund Remedial acquisitions that will substantially promote increased efficiencies across the Agency as well as increased business opportunities for both large and small businesses. Because the current RACs combine design, construction and oversight services, and do not allow for competition at the individual task level, they are not the most effective type of contract to meet the governments needs. Therefore, the Agency will no longer use RACs to meet Superfund remedial program requirements after the RAF is in place and existing contracts expire. Instead, requirements will be met with three different suites of contracts, which ensure no conflicts of interest and maximize competition through multiple award contracts (MAC) and competition at the task order level.
