NAICS: 562910. This solicitation shall result in one 4-year contract with one 6-month option to extend services at DFSP Pt. Loma, CA. The Government and contractor shall enter into a firm-fixed-price performance-based contract. Facility operations have resulted in multiple reported releases of petroleum hydrocarbon compounds into the subsurface from several of the tank systems at the site. DFSP Pt. Loma soil and groundwater contamination consists of NAPL and the degradation products. Recovery efforts have been ongoing since 2004. The scope of services to be performed include on-site project management (phase-in, continuing, and phase-out); groundwater and NAPL remediation system operation, maintenance, and reporting; environmental monitoring and reporting; data management; extraordinary site support; and off-site environmental support. For purposes of this contract, off-site is defined as any DLA Installation Support for Energy (DS-FEE)-directed location within California and within 125 miles of the site. DLA may request a proposal from contractor to conduct off-site environmental services at other active or former military installations within the 125-mile radius (excluding services at DFSP San Pedro and DFSP Norwalk and their associated pipelines). OFFERS MUST BE RECEIVED BY 1:00 PM ET ON SEPTEMBER 28, 2017.

NAICS: 562910. THE SOLICITATION DOCUMENTS FOR THIS PROJECT WILL BE AVAILABLE ON OR ABOUT SEPTEMBER 25, 2017, via FedBizOpps under solicitation number W912DW-17-R-0003. The solicitation will facilitate award of up to five contracts with a maximum shared capacity of \$75M. Contracts will have a base period of three years and an option to extend the contract for an additional two-year period. THIS IDIQ MULTIPLE-AWARD TASK-ORDER CONTRACT (MATOC) IS SET ASIDE FOR QUALIFIED 8(A) FIRMS with active SAM registration under NAICS code 562910 (Environmental Remediation Services). The Pre-placed Remedial Action Contract will support work for existing and future customers of the five districts (Seattle, Walla Walla, Portland, Kansas City, and Omaha) within the USACE Northwestern Division, which has a geographic footprint covering Washington, Oregon, Idaho, Montana, North Dakota, South Dakota, Minnesota, Wisconsin, Wyoming, Nebraska, Iowa, Colorado, Kansas, and Missouri. In addition, this MATOC includes missions for EPA Region 2 (New York and New Jersey). This contract for environmental response actions will include service and construction activities mandated by the Defense Environmental Restoration Program (DERP); EPA actions under CERCLA and the Brownfields Program; environmental compliance and pollution prevention projects under DoD's Environmental Quality Program; FUSRAP; environmental cleanup activities under the BRAC Program; Department of Homeland Security and FEMA; and other environmental and homeland security laws and regulations requiring support activities for military installations, Corps' civil works projects, and work for other federal agencies. The DERP projects will include Installation Restoration Program activities on active Army and Air Force installations and on Formerly Used Defense Sites.

Army Corps of Engineers, Engineer Research and Development Center intends to negotiate on a sole-source basis (IAW FAR 13.106-1b) with Jackson State University, 1400 J R Lynch St., Ste. 206, Jackson, MS 39217-0002, as the only responsible source (due to their previous developments, experience, and knowledge of computational methods of munitions in the environment) that can provide the research required to investigate other reactive species, such as singlet oxygen and solvated electron, which can also cause degradation of IM compounds in the aqueous environment.
