NAVFAC SW, San Diego, will be conducting a second Industry Day to update interested firms about its upcoming requirement for a cost-type contract for remedial actions (focusing on post-ROD stages) at environmentally contaminated sites, predominately at Navy and Marine Corps installations. The sites will consist of those ranked on the Superfund NPL as well as non-NPL sites regulated under CERCLA, RCRA, UST, MMRP, and other sites that might require remedial action. Requirements may focus primarily on environmental restoration, but could involve other environmental work such as compliance. The work to be ordered under this contract will be performed at various locations within the NAVFAC SW footprint, mainly located in California, Arizona, Nevada, Utah, New Mexico, and Colorado as well as in Alaska, Hawaii, Idaho, Montana, Oregon, and Washington. However, the majority of the work is expected to be performed in California. The NAICS code for this future acquisition is 562910 (Remediation Services). It is anticipated that the resultant contract term will be for a one 24-month base period and one 36-month ordering period, for a total maximum contract term of five years. The aggregate maximum dollar value of this procurement, including the base year and the ordering period shall not exceed \$240M. In addition to providing an update on the forthcoming requirement, the Industry Day will allow NAVFAC SW to obtain valuable feedback from prospective offerors. The Alaska Fire Service (AFS) Headquarters is located on Fort Wainwright Army Installation near Fairbanks, Alaska. Building 1541 on Gaffney Road has a communications tower adjacent at the southwest corner that was constructed prior to 1968. The tower is approximately 65 feet tall and is painted with orange and white lead-based paint. The tower is listed in the Fort Wainwright historic district as part of the Ladd Field National Historic Landmark. On 2008, AFS hired a contractor to test the paint on the tower for lead content and leaching potential, test the adjacent air intake ducts for Building 1541 for lead dust/paint chips, and test the soil beneath the tower for lead content. The analysis in 2008 revealed the lead content of the paint to exceed the standard disposal limits so the paint must be treated as a hazardous waste for disposal; lead dust/paint chips were found in the air intake ductwork; and the soil below the tower was found to contain lead at levels exceeding the Alaska Department of Environmental Conservation standards for soil. A copy of this report will be made available to the future contractor. The objective of this project is to remove the lead-based paint on the tower and to repaint the tower in the same color and pattern; clean air intake ducts adjacent to the tower; and remove lead-contaminated surface soil surrounding the tower.
