The work will consist of removal of asbestos-containing floor tile and mastic at the Holt House at Capitol Reef National Park. Holt House has a main floor that is approximately 1000 SF. The floor tile to be removed is a double layer of floor tile and mastic that covers approximately 320 square feet. The building is used for storage at this time. All stored items will be removed from work area prior to contract work by NPS staff. The objective of this project is to remove the identified asbestos-containing material that exists inside the building prior to planned renovation work. B--CHEMICAL AND GEOTECHNICAL ANALYSES OF ENVIRONMENTAL SAMPLES (SRCSGT)

NAICS: 541380. This notice constitutes market research only to identify interested vendors for a potential requirement. The Government will review the responses received to determine the type of set-aside (if any) for this requirement, should it come to fruition. The NAICS code is 541380 (Testing Laboratories), small business size standard \$15M. The U.S. Geological Survey has a requirement for chemical analysis services of environmental (water, solid, air, and biological) samples for organic and inorganic constituents and geotechnical analyses of solid (sediment, sludge, and soil) using U.S. EPA analytical methods and other published analytical methods such as Standard Methods and ASTM methods. Legally defensible data meeting strict quality control standards are required. Analytical services may be needed for chemical and geotechnical analyses of environmental samples collected by the USGS for other regulatory-type projects requiring EPA or similar published, standardized analytical methods and well-documented analytical and quality control results. The majority of samples to be analyzed for the USGS projects will be aqueous (water) samples collected mostly from surface sources with some groundwater, sediment, and tissue samples. The contractor shall furnish all labor, materials, equipment, and facilities that are required for the geotechnical and chemical analyses. All required instruments and/or equipment shall be purchased, set up, calibrated, and online prior to award of contract. The intent of this sources sought synopsis is to identify qualified HUBZone, 8(a), woman-owned, service-disabled veteran-owned, and small businesses for a firm-fixed-price IDIQ contract for RCRA hazardous, non-RCRA, TSCA, state-regulated, non-state regulated, universal, polychlorinated biphenyls (PCBs), compressed gas cylinders (CGCs) and non-hazardous waste removal, transportation and disposal for various military and governmental activities aboard Vandenberg AFB in California and on sites contiguous to the main base. All services necessary for the collection, storage, processing, removal, transportation, final treatment, and disposal of waste will be in accordance with all local, state, Army, Air Force, Department of Defense, Navy, and federal laws and regulations. The NAICS code is 562211 (Hazardous Waste Treatment and Disposal), size standard \$38.5M. Upon review of industry response to this sources sought, the Government will determine whether a set-aside acquisition is in the Government's best interest. NAICS: 562910. THE PROPOSED CONTRACT IS 100% SET-ASIDE FOR SMALL BUSINESS CONCERNS under NAICS code 562910, size standard \$20.5M. The contractor shall provide all personnel, equipment, tools, materials, supplies, transportation, and supervision necessary to provide emergency cleaning and restorative services in the aftermath of a weather event, the consequence of failing infrastructure, or any unforeseen event requiring immediate services to mitigate harm to government property or threats to human health. Service shall be provided on an as-needed, 24-hour emergency availability basis at Wright-Patterson AFB, Ohio. Emergency cleaning requirements could be necessitated as a result of fire, firefighting efforts, malfunctioning fire suppression systems, faulty infrastructure, violence (biohazards or the presence of potentially threatening pathogens - some deriving from a human source), vandalism, storms, etc. Specific cleaning/ disinfecting/ restorative requirements will be individualized based upon the nature and the scale of the event. The contractor will be briefed on Wright-Patterson AFB spill response procedures. The contractor is responsible to report and promptly clean up all spills in a manner consistent with current environmental regulations. EPA has posted the DRAFT RFP to solicit feedback from industry, thereby to ensure that the formal solicitation is executed in the most effective manner possible.
