The capabilities package for this sources sought notice is not expected to be a proposal, but rather a short statement (10 pages max) regarding the company's ability to demonstrate existing or developed expertise and experience in relation to this contract. Upon review of industry response to this Sources Sought, the Government will determine whether a set-aside acquisition in lieu of full and open competition is in the best interest of the Government.

THIS ANTICIPATED CONTRACT WILL BE 100% SET-ASIDE FOR SMALL BUSINESS under NAICS code 562112 (size standard \$41.5M) for environmental services for hazardous waste, hazardous material, other regulated waste, and spill response for all Supported Components and Tenant Commands under Joint Region Marianas. This procurement will result in award of one combination firm-fixed-price IDIQ service contract having a maximum duration of 60 months (one base period and four 12-month options) and a maximum value of \$20M. Task orders will include operation of a conforming storage facility; management of less-than-90-day storage facilities; management of satellite accumulation sites at Naval Base Guam and initial accumulation points at Naval Support Activity Andersen; daily management, collection and disposal of hazardous material, hazardous waste, and other regulated waste, such as asbestos, lead-based paint, and PCBs; occasional management, disposal, and collection of non-HW; sampling, testing, and laboratory analysis for hazardous waste, regulated waste, and unknown waste determination; and oil and hazardous substance spill response, cleanup, sampling, laboratory analysis, and disposal. This is a new procurement. It does not replace an existing contract. RELEASE OF THE RFP IS ANTICIPATED ON OR ABOUT OCTOBER 25, 2019.
