The buildings are townhouses and small single-family homes; testing is being conducted in the five occupied units, which are the same in plan and in close proximity to one another. The survey shall include all interior and exterior wood surfaces. Flat wall and ceiling surfaces are NOT part of the scope. Wallboard corners that are considered chewable must be tested. Entryway floors shall also be tested. Surfaces damaged by testing processes will be repaired by Coast Guard personnel. The contractor shall provide a report. The inspection process shall determine what surfaces must be brought into compliance with lead paint regulations. The Internal Revenue Service, Office of Treasury Procurement Services has requirement for RESTORE Act Subject Matter Expert Services. The Gulf RESTORE Act (July 6, 2012) established the Gulf Coast Restoration Trust Fund in the U.S. Treasury to contain penalties paid under the Federal Water Pollution Control Act in connection with the Deepwater Horizon Oil Spill. The Act is focused on restoring and protecting the environment and economy in Alabama, Florida, Louisiana, Mississippi, and Texas. Use of these funds is organized in 5 parts. Part 1: the Direct Component sets aside 35% of the penalties paid into the Trust Fund for eligible activities proposed by the five Gulf Coast States, including local governments within Florida and Louisiana. Part 2: The Comprehensive Plan Component provides 30% of the penalties, plus one-half of all interest earned on Trust Fund investments, to the federal Gulf Coast Ecosystem Restoration Council, which directs those funds to projects and programs for the restoration of the Gulf Coast region, pursuant to the Council's Comprehensive Plan. Part 3: The Spill Impact Component uses an additional 30% for grants directed by the Council to the Gulf Coast States for activities consistent with the Comprehensive Plan. Part 4: The RESTORE Science Program provides 2.5% of the Trust Fund and one-quarter of all interest earned on Trust Fund investments to carry out research, observation, and monitoring to support long-term sustainability of the ecosystem and the Gulf. Part 5: The Centers of Excellence Research Grants use 2.5% of the Trust Fund and one-quarter of all interest earned on Trust Fund investments to establish centers to conduct research on the coastal ecosystem, economy, and energy development. Expenditures from the Trust Fund for the Direct Component activities and the Centers for Excellence Research Grants are in the form of grants, which Treasury will administer. The financial management, auditing, and reporting requirements in federal grant law, therefore, apply to these expenditures. There are 47 eligible applicants for the Direct Component and 4 eligible entities for the Centers of Excellence Research Grants Program. Treasury shall require the contractor to review and assess the reasonable use of best available science in Direct Component applications for projects with natural resource protection and restoration objectives, review an applicant's (or, in some cases, a grantee's) environmental compliance for relevant Direct Component and Centers of Excellence projects, and conduct on-site reviews of Direct Component construction projects. Duration of the period of performance is one base year and 2 option years. The Government anticipates awarding a hybrid IDIQ contract that allows for firm-fixed-price and labor-hour task orders.
