F -- ASBESTOS ABATEMENT & CARPET INSTALL (SOL)

NAICS: 562910. THIS IS A TOTAL SMALL BUSINESS SET-ASIDE. The U.S. Department of the Air Force seeks a contractor to perform asbestos abatement containing floor materials in Rooms 160, 161, and a closet in room 161 of Building 10480 at Joint Base Elmendorf-Richardson in Alaska. Work includes the removal of approximately 800 SF of flooring material that may consist of or be a combination of carpet, vinyl tile, floor adhesive, or other material that may contain asbestos. The contractor will be responsible for abating the floor to bare concrete and applying a coating of encapsulant when abatement is complete. After abatement, the contractor will install 28 oz. nylon broadloom carpet in rooms 160, 161, and a closet in room 161 and apply a new cove base in rooms 160, 161, and a closet in room 161. Work also includes the handling of lead-based paint and asbestos containing material encountered during any phase of the work; the transport and disposal of all removed non-hazardous lead-based paint and asbestos materials, waste, and debris, to include the preparation and signing of all DOT required manifests; and lead-based paint and asbestos air sampling (accomplished by an EPA certified inspector or an Industrial Hygienist) of work area to demonstrate compliance with 29 CFR 1926 to ensure the area does not exceed permissible code standards and is safe for occupancy or re-occupancy. The magnitude of construction in accordance with FAR 36.204(b) is between \$25,000 and \$100,000. The period of performance will be 365 calendar days from the Notice to Proceed. The U.S. Department of Agriculture Forest Service requires a contractor to conduct "expanded" pre-acquisition environmental site assessments in accordance with 40 CFR 312, 33 CFR 137 and ASTM Standard E1527-13 at sites in Ozark County, Missouri. The overall purpose of these "expanded" pre-acquisition environmental site assessments is that the Agency needs to know the full range of "environmental issues and liabilities" associated with the parcel(s). The Agency requires identification of the environmental issues and liabilities with the parcel beyond those associated with Comprehensive Environmental Response, Compensation and Liability Act (CERCLA) liabilities and petroleum products. These environmental issues and liabilities include, but are not limited to, those issues and liabilities under the Resource Conservation and Recovery Act (RCRA), the Safe Drinking Water Act (SDWA), the Clean Air Act (CAA), the Clean Water Act (CWA), the Toxic Substance Control Act (TSCA). These issues and liabilities include, but are not limited to, asbestos-containing material, radon, lead-based paint, non-hazardous solid waste disposal areas, wastewater disposal systems, drinking water systems, drinking water, and/or other wells. In conducting the "expanded" pre-acquisition environmental site assessment, the contractor shall consider the proposed future land use of the parcel/s. Some issues/liabilities, which typically may be "de minimis" for the current land use, may not "de minimis" when the Agency's planned future land use (for example, open forest preserve or wildlife refuge) is taken into account. The U.S. Department of Agriculture Forest Service requires professional services to provide emergency Hazardous Material (HAZMAT) release response and clean-up on National Forest System Lands located in Region 5. Services performed under this requirement may be subject to regulatory review and approval by Federal, state, and local regulatory agencies (i.e. the Environmental Protection Agency [EPA], the Regional Water Quality Control Board, etc.) Depending on the complexity of a project, intermediate reviews may be required by the Government. The Contractor shall prepare any necessary responses for the Government to comments generated by these regulatory agency reviews, provide any additional information requested, and modify the final document(s) as needed. The Contractor will consult with and provide

technical data and advice to USFS officials and staff; and will be expected to attend, report, and advise at meetings and conferences with regulators and other parties, and analyze any other data pertinent to the projects when required. Projects may be located anywhere throughout the USFS Pacific Southwest Region 5, which includes 18 National Forests located primarily in California with some small acreage along the California/Nevada border and the California/Oregon border. Some work may encompass private land adjacent to these National Forest lands. All projects will be negotiated and awarded as a Task Order under the Indefinite Delivery Indefinite Quantity (IDIQ) contract. The purpose of these assessments and surveys are to gather sufficient information to develop an independent professional opinion about the environmental condition of the property and to identify actual or potential environmental contamination. The contractor shall provide a certified inspector/s to perform the Phase 1 ESA per ASTM E1527-21. A hazardous material and asbestos building and site survey shall also be provided for the buildings. The contractor shall review the building and conduct a site investigation to determine the site conditions. The building and site may be disturbed only as necessary to inspect and understand the environmental hazards that may be present. Bulk samples from suspected hazardous materials shall be collected to be further tested at a certified laboratory using appropriate standard testing methods as necessary. The contractor shall ensure all personnel is using appropriate personal protective equipment while on site. The award will be a firm-fixed-price contract. Task Orders are expected to include a broad range of work to prepare remediation plans and abatement strategies, perform activities according to those plans and strategies to support maintenance, repair, alteration, and clean-up of real property at JBER.
