NAICS: 562910. THIS IS A FULL AND OPEN COMPETITION. The U.S. Army Corps of Engineers, Kansas City District, requires a contractor to perform under a single, stand-alone contract for the Raritan Bay Slag Superfund Site Operable Unit 1 - Seawall Sector Remedial Action. Remediation will consist of the dredging/excavation and removal of source materials (i.e., pieces of slag comingled with crushed battery casing materials and associated wastes that act as sources of contamination), and contaminated soil/sediment from the areas located in the Seawall Sector. Source materials, contaminated soil/sediment, riprap/armored stone, and miscellaneous debris will be removed. The Remedial Action Objectives (RAOs) are organized into these categories: slag, battery casings, and associated wastes, which comprise the highly toxic source material principal threat waste (PTW); soil; sediment; and surface water. NAICS: 562910. WHEN THIS SOLICITATION IS RELEASED ON OR ABOUT NOVEMBER 21, 2025, IT WILL BE COMPETED AS A SERVICE-DISABLED VETERAN-OWNED SMALL BUSINESS SET-ASIDE. The U.S. Department of Veterans Affairs (VA) requires the abatement of asbestos-containing pipe insulation in Building 76 at the VA Medical Center in Bath, New York. Because the facility is fully operational, the VA may restrict work hours and require off-tour work as directed by the Contracting Officer's Representative (COR) to avoid disrupting medical center operations. The contractor will have 30 days from the Notice to Proceed to complete all work. The estimated cost range is \$25,000 to \$100,000. NAICS: 562910. WHEN THIS SOLICITATION IS RELEASED, IT WILL BE COMPETED AS A TOTAL SMALL BUSINESS SET-ASIDE. The U.S. Department of Defense, Defense Logistics Agency, requires a contractor to remove lead-based paint from the ceiling of Building 98 at the Defense Supply Center in Richmond, Virginia. The paint has been peeling and chipping, falling onto occupants' desks and creating a biohazard, and larger sections have been falling throughout the warehouse, causing work stoppages. Specific requirements include removing paint without chemical strippers, ensuring all workers wear appropriate PPE, and properly collecting and disposing of lead-containing waste off site. The contractor must also demobilize, obtain a third-party clearance test confirming the area is safe, dispose of all contaminated materials (including tarps, HEPA filters, and non-reusable PPE) in accordance with EPA requirements, and provide all post-abatement test results to the Project Manager/Contracting Officer Representative. Interested contractors must be within a commutable 120-mile driving distance of the DSCR facility. The award will be made to the lowest-priced, technically acceptable (LPTA) offeror that meets the requirements stated in the Statement of Work and the solicitation. All offerors shall be normally engaged in construction and maintenance as their primary line of business and shall have at least five years of documented experience working with paint and paint-removal materials. The completion date for this work shall be no later than 90 days after the Notice to Proceed. There is no solicitation at this time.
