Contractor is to provide spill response and spill cleanup services for oil and chemicals at Watervliet Arsenal. Responding on an as-needed basis, Contractor shall furnish all services, materials, supplies, equipment and travel required as well as sufficient technical, supervisory, and administrative personnel to ensure the expeditious accomplishment of the work specified in the Statement of Work. Watervliet Arsenal (WVA) is an industrial facility located in Watervliet, New York, that manufactures cannons and large caliber weapon systems. WVA stores and handles large quantities of petroleum oil products and hazardous chemicals during routine operations. The installation is located less than 500 feet from the Hudson River and has a stormsewer system that discharges to both the Hudson River and the Kromma Kill. The scope of this contract involves different levels of response to a petroleum or hazardous materials spill on an as-needed basis. Spills may occur and travel to any of several surface types and/or environmental receptors. These include but are not limited to concrete, asphalt, wood block flooring, stone, soil, storm sewer catch basins, the local waterways, etc. Spills may occur at any time of day or night. Contractor will remove and clean up the spilled material, absorbent material, other impacted materials, and clean all affected surfaces. Contractor is responsible for final cleanup of the spilled material, which might include continued maintenance cleaning to completely remove all spilled material and clean affected surfaces. The U.S. Geological Survey (USGS) conducts various types of scientific projects with DoD and other governmental agencies throughout the United States and other countries under the USGS DoD Environmental Conservation (DODEC) program. These DODEC projects investigate various types of contamination-related problems and conduct environmental studies at federal facilities. Typically these projects require analytical services for chemical analyses of environmental (water, solid, air, and biological) samples for organic and inorganic constituents, and geotechnical analyses of solid (sediment, sludge, and soil) samples using U.S. EPA analytical methods and other published analytical methods, such as Standard Methods and ASTM methods. The majority of samples to be analyzed for the USGS projects will be aqueous (water) samples collected mostly from surface sources with some groundwater, sediment, and tissue samples. The environmental samples to be analyzed by the Contractor will be collected by USGS. The Phase 1B area of the Mississippi Phosphate East Gypsum Stack consists of approximately 50 acres of contaminated material in need of a permanent and impermeable covering to prevent runoff to nearby environmentally sensitive sites. The Government will purchase and provide to the selected contractor sufficient quantities to cover the estimated 50-acre project area. Additional sand/concrete infill will be required to be purchased and provided under the contract resulting from the upcoming solicitation. The contractor ultimately selected for the installation work must be trained and certified by Watershed Geo in the installation of ClosureTurf. The selected contractor must also demonstrate a history of successful performance in previous ClosureTurf installations.
