Contaminants of concern include beryllium, lead, radium-226, thorium-230, uranium-234, and uranium-238 in soils, sediments, fill materials, other miscellaneous debris, and groundwater. Remediation services are currently being performed on site by North Wind Portage. The work and services shall consist of environmental remediation and support for the U.S. Army Corps of Engineers, Buffalo, New York District. The project focus consists of excavation, transport, and disposal of FUSRAP-contaminated soil, sediment, and materials at a properly licensed facility. Additional activities may include overall site maintenance and security; project management and construction quality assurance/quality control; preparation of project work plans and engineering design for USACE approval; perimeter air monitoring during the remedial action; sampling and analysis of excavated soils/fill; operation of an on-site laboratory; storm water and wastewater management and control; decommissioning and installation of monitoring wells; remedial compliance sampling and analysis; backfilling and restoration of remediated areas; and supporting USACE during meetings with the public, local officials, and regulators.
